**ANNOUNCEMENT**  
**CONTINUING CONNECTED TRANSACTIONS: ENTERING**  
**INTO NEW NETWORK AGREEMENTS**

Reference is made to the announcement of the Company dated 31 December 2021 in relation to the entering into of the Old Network Agreements between the Company and Anhui Expressway Network Operations and United Card Holding.

The Old Network Agreements expired on 31 December 2023. The Board announces that on 4 January 2024, the Company and certain subsidiaries of the Company, namely Guangci Company, Ningxuanhang Company, Anqing Bridge Company and Xuanguang Company (as the service users) entered into the following network services agreements and ETC services agreements (hereinafter collectively referred to as the “**New Network Agreements**”) with Anhui Expressway Network Operations and United Card Holding (as the service providers), respectively, to continue to carry out the transactions under the Old Network Agreements.

- Pursuant to the New Network Services Agreement I, the Company shall engage Anhui Expressway Network Operations to provide the Network Services to the Company for the toll expressways held and operated by the Company within Anhui Province;
- Pursuant to the New Network Services Agreement II, Guangci Company shall engage Anhui Expressway Network Operations to provide the Network Services to Guangci Company for the toll expressways held and operated by Guangci Company within Anhui Province;
- Pursuant to the New Network Services Agreement III, Ningxuanhang Company shall engage Anhui Expressway Network Operations to provide the Network Services to Ningxuanhang Company for the toll expressways held and operated by Ningxuanhang Company within Anhui Province;

- Pursuant to the New Network Services Agreement IV, Anqing Bridge Company shall engage Anhui Expressway Network Operations to provide the Network Services to Anqing Bridge Company for the toll expressways held and operated by Anqing Bridge Company within Anhui Province;
- Pursuant to the New Network Services Agreement V, Xuanguang Company shall engage Anhui Expressway Network Operations to provide the Network Services to Xuanguang Company for the toll expressways held and operated by Xuanguang Company within Anhui Province;
- Pursuant to the New ETC Services Agreement I, the Company shall engage United Card Holding to provide ETC Services to the Company for the toll expressways held and operated by the Company within Anhui Province;
- Pursuant to the New ETC Services Agreement II, Guangci Company shall engage United Card Holding to provide ETC Services to Guangci Company for the toll expressways held and operated by Guangci Company within Anhui Province;
- Pursuant to the New ETC Services Agreement III, Ningxuanhang Company shall engage United Card Holding to provide ETC Services to Ningxuanhang Company for the toll expressways held and operated by Ningxuanhang Company within Anhui Province;
- Pursuant to the New ETC Services Agreement IV, Anqing Bridge Company shall engage United Card Holding to provide ETC Services to Anqing Bridge Company for the toll expressways held and operated Anqing Bridge Company within Anhui Province;
- Pursuant to the New ETC Services Agreement V, Xuanguang Company shall engage United Card Holding to provide ETC Services to Xuanguang Company for the toll expressways held and operated Xuanguang Company within Anhui Province.

Anhui Transportation Holding Group is currently holding approximately 31.63% of the total issued shares of the Company, and is the controlling shareholder and a connected person of the Company as defined under the Listing Rules. As Anhui Expressway Network Operations is a wholly-owned subsidiary of Anhui Transportation Holding Group, and United Card Holding is a wholly-owned subsidiary of Anhui Expressway Network Operations, under Chapter 14A of the Listing Rules, Anhui Expressway Network Operations and United Card Holding are both associates of Anhui Transportation Holding Group and are therefore also connected persons of the Company. Accordingly, the transactions under the New Network Agreements constitute continuing connected transactions of the Group.

As the continuing connected transactions under the New Network Agreements are interconnected, they may be aggregated and treated as if they were one transaction in accordance with the requirements under Rules 14A.81 and 14A.83 of the Listing Rules.

Since the highest applicable percentage ratio in respect of the continuing connected transactions under the New Network Agreements on annual and aggregated basis is more than 0.1% but less than 5%, and such transactions are conducted on normal commercial terms, they are exempt from the requirement of approval by independent shareholders of the Company, but shall be subject to the reporting, announcement and annual review requirements under Chapter 14A of the Listing Rules.

## **NEW NETWORK SERVICES AGREEMENT I**

### **Date**

4 January 2024

### **Parties**

- (1) The Company (as the service user);
- (2) Anhui Expressway Network Operations (as the service provider).

### **Subject Matter**

Under the New Network Services Agreement I, Anhui Expressway Network Operations shall provide Network Services to the Company for the toll expressways held and operated by the Company within Anhui Province.

### **Term of Services**

The term of services is from 1 January 2024 to 31 December 2026.

### **Basis for Services Fees and Payment Terms**

The Company shall pay to Anhui Expressway Network Operations the operation service fees of the toll collection road network for the previous quarter at the rate of not more than 0.23% of final toll fees calculated through the settlement network for each quarter within one month after split settlement for each quarter. The aforesaid rate is determined in accordance with the requirements of the Management Committee and the provisions of the Toll Collection Network Operation Services Fee Charging Model of Anhui Province\* (《安徽省聯網收費路網運行服務費收費模式》).

## **NEW NETWORK SERVICES AGREEMENT II**

Except for the following amendments, other major terms of the New Network Services Agreement II shall be the same as those set out in the New Network Services Agreement I:

- The party shall be changed from the Company to Guangci Company;
- Guangci Company shall engage Anhui Expressway Network Operations to provide the Network Services to Guangci Company for the toll expressways held and operated by Guangci Company within Anhui Province.

## **NEW NETWORK SERVICES AGREEMENT III**

Except for the following amendments, other major terms of the New Network Services Agreement III shall be the same as those set out in the New Network Services Agreement I:

- The party shall be changed from the Company to Ningxuanhang Company;
- Ningxuanhang Company shall engage Anhui Expressway Network Operations to provide the Network Services to Ningxuanhang Company for the toll expressways held and operated by Ningxuanhang Company within Anhui Province.

## **NEW NETWORK SERVICES AGREEMENT IV**

Except for the following amendments, other major terms of the New Network Services Agreement IV shall be the same as those set out in the New Network Services Agreement I:

- The party shall be changed from the Company to Anqing Bridge Company;
- Anqing Bridge Company shall engage Anhui Expressway Network Operations to provide the Network Services to Anqing Bridge Company for the toll expressways held and operated by Anqing Bridge Company within Anhui Province.

## **NEW NETWORK SERVICES AGREEMENT V**

Except for the following amendments, other major terms of the New Network Services Agreement V shall be the same as those set out in the New Network Services Agreement I:

- The party shall be changed from the Company to Xuanguang Company;
- Xuanguang Company shall engage Anhui Expressway Network Operations to provide the Network Services to Xuanguang Company for the toll expressways held and operated by Xuanguang Company within Anhui Province.

# **NEW ETC SERVICES AGREEMENT I**

## **Date**

4 January 2024

## **Parties**

- (1) The Company (as the service user);
- (2) United Card Holding (as the service provider).

## **Subject Matter**

Under the New ETC Services Agreement I, United Card Holding shall provide ETC Services to the Company for the toll expressways held and operated by the Company within Anhui Province.

## **Term of Services**

The term of services is from 1 January 2024 to 31 December 2026.

## **Basis for Services Fees and Payment Terms**

The Company shall pay to United Card Holding the operation service fees of the toll collection road network for the previous quarter at 0.33% of final toll fees calculated through the settlement network for each quarter within one month after split settlement for each quarter. The aforesaid rate is determined in accordance with the requirements of the Management Committee and the provisions of the Toll Collection Network Operation Services Fee Charging Model of Anhui Province\* (《安徽省聯網收費路網運行服務費收費模式》).

## **NEW ETC SERVICES AGREEMENT II**

Except for the following amendments, other major terms of the New ETC Services Agreement II shall be the same as those set out in New ETC Services Agreement I:

- The party shall be changed from the Company to Guangci Company;
- Guangci Company shall engage United Card Holding to provide ETC Services to Guangci Company for the toll expressways held and operated by Guangci Company within Anhui Province.

## **NEW ETC SERVICES AGREEMENT III**

Except for the following amendments, other major terms of the New ETC Services Agreement III shall be the same as those set out in New ETC Services Agreement I:

- The party shall be changed from the Company to Ningxuanhang Company;
- Ningxuanhang Company shall engage United Card Holding to provide ETC Services to Ningxuanhang Company for the toll expressways held and operated by Ningxuanhang Company within Anhui Province.

## **NEW ETC SERVICES AGREEMENT IV**

Except for the following amendments, other major terms of the New ETC Services Agreement IV shall be the same as those set out in New ETC Services Agreement I:

- The party shall be changed from the Company to Anqing Bridge Company;
- Anqing Bridge Company shall engage United Card Holding to provide ETC Services to Anqing Bridge Company for the toll expressways held and operated Anqing Bridge Company within Anhui Province.

## **NEW ETC SERVICES AGREEMENT V**

Except for the following amendments, other major terms of the New ETC Services Agreement V shall be the same as those set out in New ETC Services Agreement I:

- The party shall be changed from the Company to Xuanguang Company;
- Xuanguang Company shall engage United Card Holding to provide ETC Services to Xuanguang Company for the toll expressways held and operated Xuanguang Company within Anhui Province.

The estimated Annual Caps have been determined with reference to factors including (1) the proposed basis for fees for the Network Services and ETC Services as disclosed in this announcement; (2) the historical utilization volume of the Network Services and ETC Services; (3) the expected utilization volume of the Network Services and ETC Services; and (4) the development plans of the Group, etc.

The total consideration for the Network Services and ETC Services will be paid by the Group through its own funds.

## **REASONS FOR AND BENEFITS OF ENTERING INTO THE NEW NETWORK AGREEMENTS**

Accepting the Network Services and ETC Services forms part of the ordinary and usual course of business of the Group. In accordance with the relevant requirements of the Management Committee and the provisions of the Toll Collection Network Operation Services Fee Charging Model of Anhui Province\* (《安徽省聯網收費路網運行服務費收費模式》), Anhui Expressway Network Operations shall charge road operation service fee based on the rate of not more than 0.23% of the toll calculated through the network settlement, and such fee shall be used for works such as ensuring service security of network toll and road operation, etc.; and United Card Holding shall charge road operation service fee based on the rate of 0.33% of the toll calculated through the network settlement, and such fee shall be used for works such as ETC issuance, operation, customer services, promotion and application, travel services, etc. The Company, Guangci Company, Ningxuanhang Company, Anqing Bridge Company and Xuanguang Company will enter into the New Network Services Agreements and the New ETC Services Agreements with Anhui Expressway Network Operations and United Card Holding, respectively, with respect to the Network Services and ETC Services for the years 2024, 2025 and 2026, to reflect the providers of Network Services and ETC Services and new toll collection model.



## **IMPLICATIONS OF THE LISTING RULES**

Anhui Transportation Holding Group is currently holding approximately 31.63% of the total issued shares of the Company, and is the controlling shareholder and a connected person of the Company as defined under the Listing Rules. As Anhui Expressway Network Operations is a wholly-owned subsidiary of Anhui Transportation Holding Group, and United Card Holding is a wholly-owned subsidiary of Anhui Expressway Network Operations, under Chapter 14A of the Listing Rules, Anhui Expressway Network Operations and United Card Holding are both associates of Anhui Transportation Holding Group and are therefore also connected persons of the Company. Accordingly, the transactions under the New Network Agreements constitute continuing connected transactions of the Group.

As the continuing connected transactions under the New Network Agreements are interconnected, they may be aggregated and treated as if they were one transaction in accordance with the requirements under Rules 14A.81 and 14A.83 of the Listing Rules.

Since the highest applicable percentage ratio in respect of the continuing connected transactions under the New Network Agreements on annual and aggregated basis is more than 0.1% but less than 5%, and such transactions are conducted on normal commercial terms, they are exempt from the requirement of approval by independent shareholders of the Company, but shall be subject to the reporting, announcement and annual review requirements under Chapter 14A of the Listing Rules.

## **CONFIRMATION OF THE BOARD**

The Board has considered the resolution on the New Network Agreements. Xiang Xiaolong and Chen Jiping, who are the directors of the Company, are directors or senior management of Anhui Transportation Holding Group and/or directors nominated by Anhui Transportation Holding Group. Therefore, Xiang Xiaolong and Chen Jiping are considered to have interests in the New Network Agreements, and have abstained from voting on the resolution on the connected transactions under the New Network Agreements in accordance with the Listing Rules. Save as aforesaid, none of the directors has any material interests in the New Network Agreements or is required to abstain from voting on the relevant Board resolution.

The Board (including independent non-executive directors) is of the view that the terms and the Annual Caps of the New Network Agreements are (i) fair and reasonable; (ii) on normal commercial terms or better terms in the ordinary and usual course of business of the Group; and (iii) in the interests of the Company and its shareholders as a whole.

## **INFORMATION ON THE PARTIES INVOLVED IN NEW NETWORK AGREEMENTS**

The Company is principally engaged in the holding, operation and development of toll expressways and highways within Anhui Province.

Guangci Company is principally engaged in the charging, maintenance, obstacles removal services and operation management of Guangci Expressway.

Ningxuanhang Company is principally engaged in the construction, collection of toll, maintenance, management and related advertisement service of high grade highways.

Xuanguang Company is principally engaged in the collection of toll, maintenance and obstacles removal services of Xuanguang Expressway; repairing of automobiles and construction engineering machineries; food and beverage; wholesale and retail sales of automobile accessories, department store products.

Anqing Bridge Company is principally engaged in bridge construction and fund raising, materials supply, tertiary industry operation and bridge operation and management services.

Anhui Expressway Network Operations is principally engaged in construction, operation and service of Anhui transportation cards (including urban public transportation cards), expressway network toll (including electronic toll collection (ETC)), electronic payment (mobile payment); investment, construction, operation and service of intelligent transportation project; information system and software development and production inspection and test; intelligent transportation related-hardware and software products sale; integration, development, operation and service of information and resources; research and development and promotion of new technology and products of intelligent transportation; information technology consultation, training and services. (for projects subject to approval in accordance with the laws, business activities can only be carried out after being approved by relevant departments)

United Card Holding is principally engaged in the issuance, sales and operation services of Huitong Cards\* (徽通卡) (ETC cards) and electronic tags; the construction, operation and services of electronic highway toll and transportation card electronic payment platforms; the integrated services of information systems; the operation and maintenance services of information systems; investment, construction, operation and services of intelligent transportation projects; the research and development and promotion of new technologies and products of intelligent transportation; call center and public travel information services. (for projects subject to approval in accordance with the laws, business activities can only be carried out after being approved by relevant departments)
